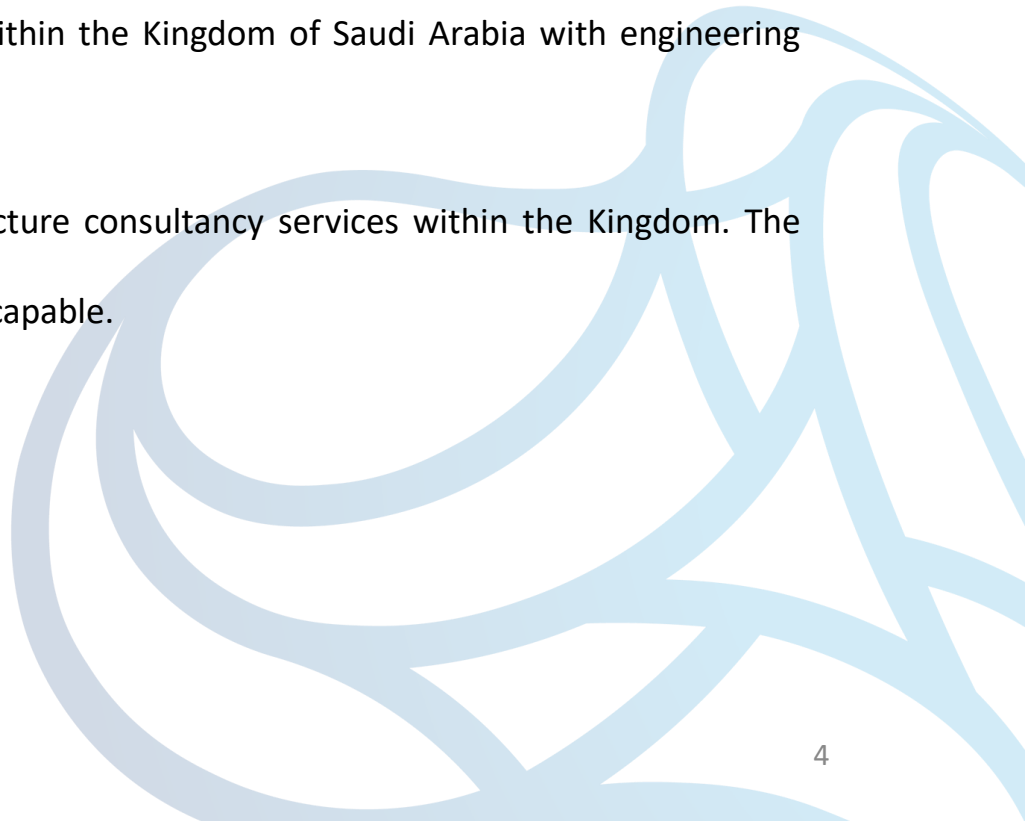
Company History

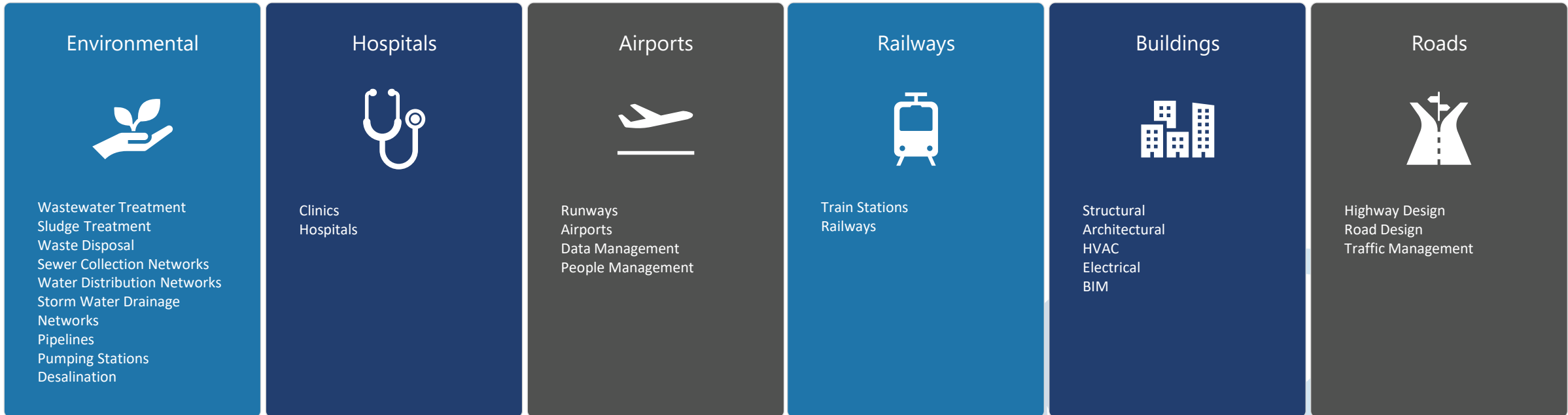


Mission and Vision

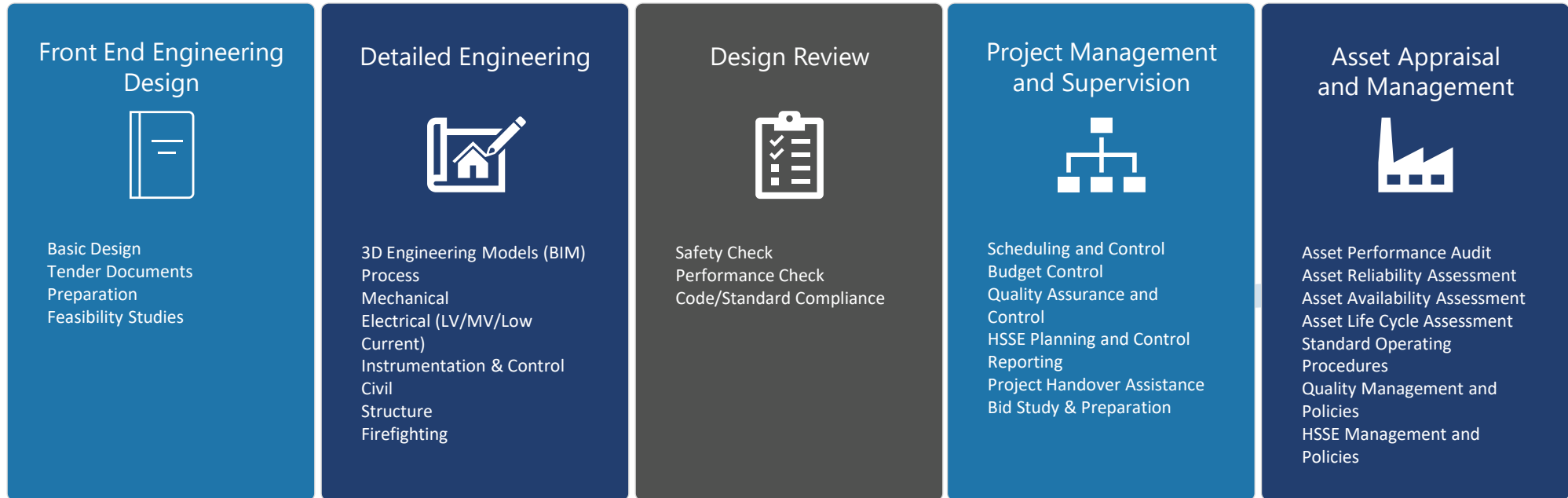

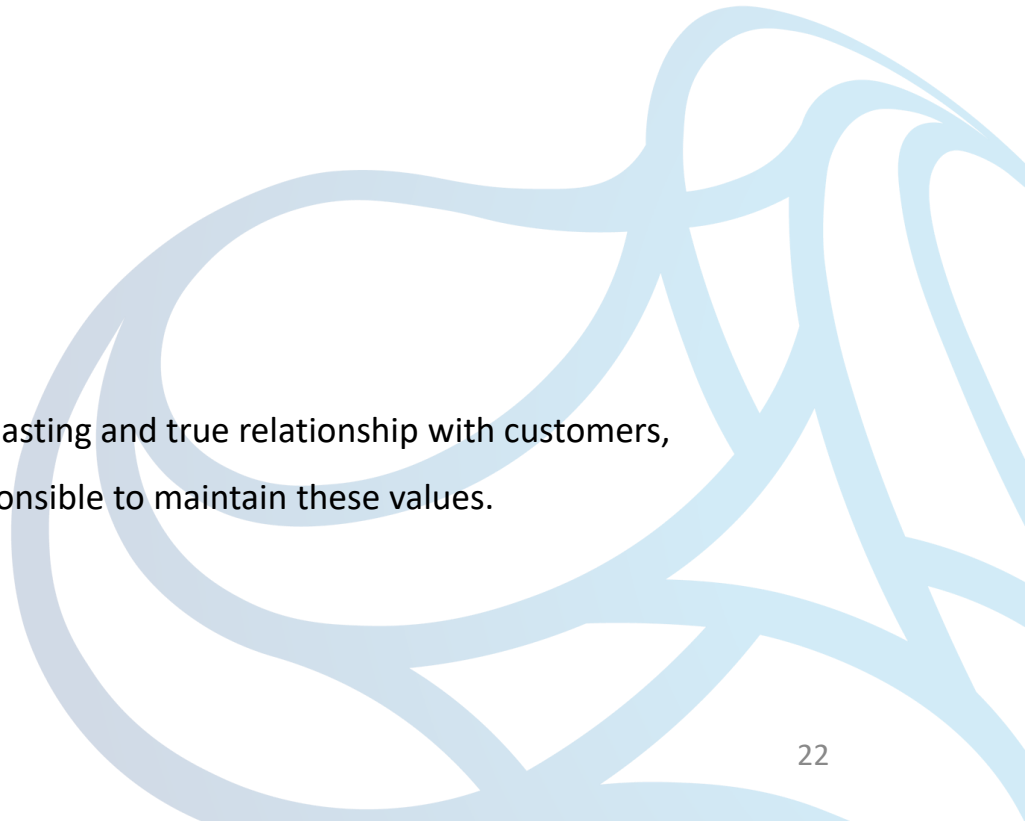
Core Values

- Investigate all accidents and implement all recommendations to prevent reoccurrence.

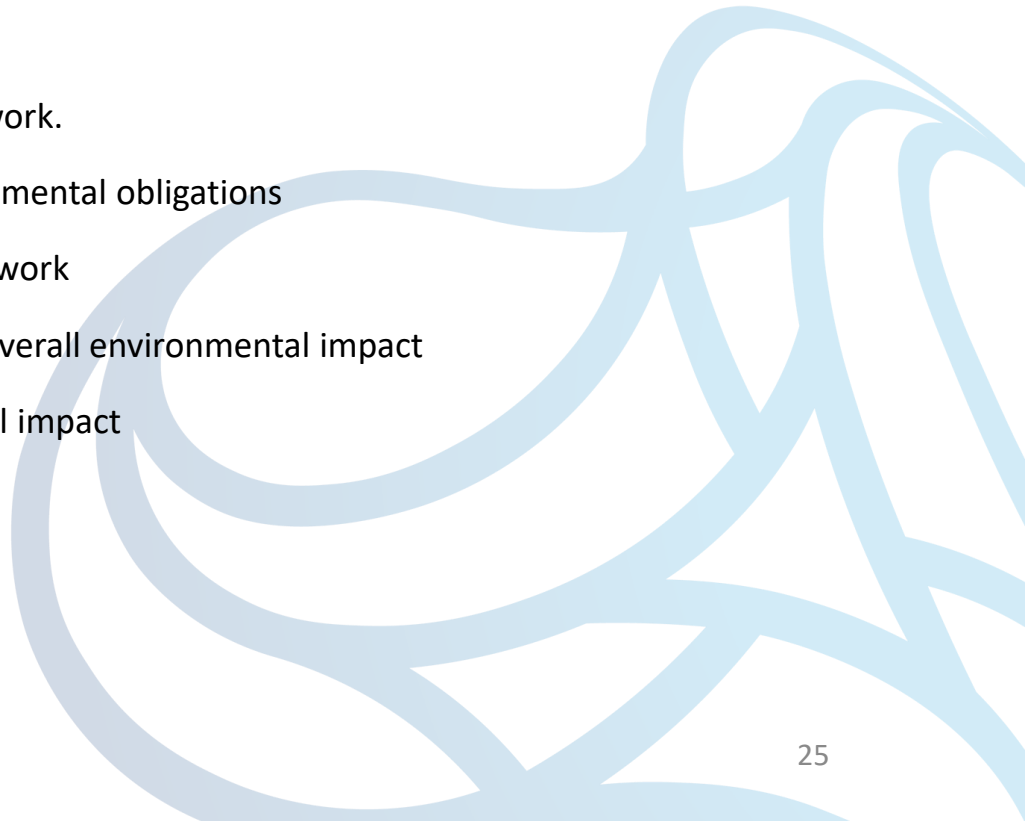

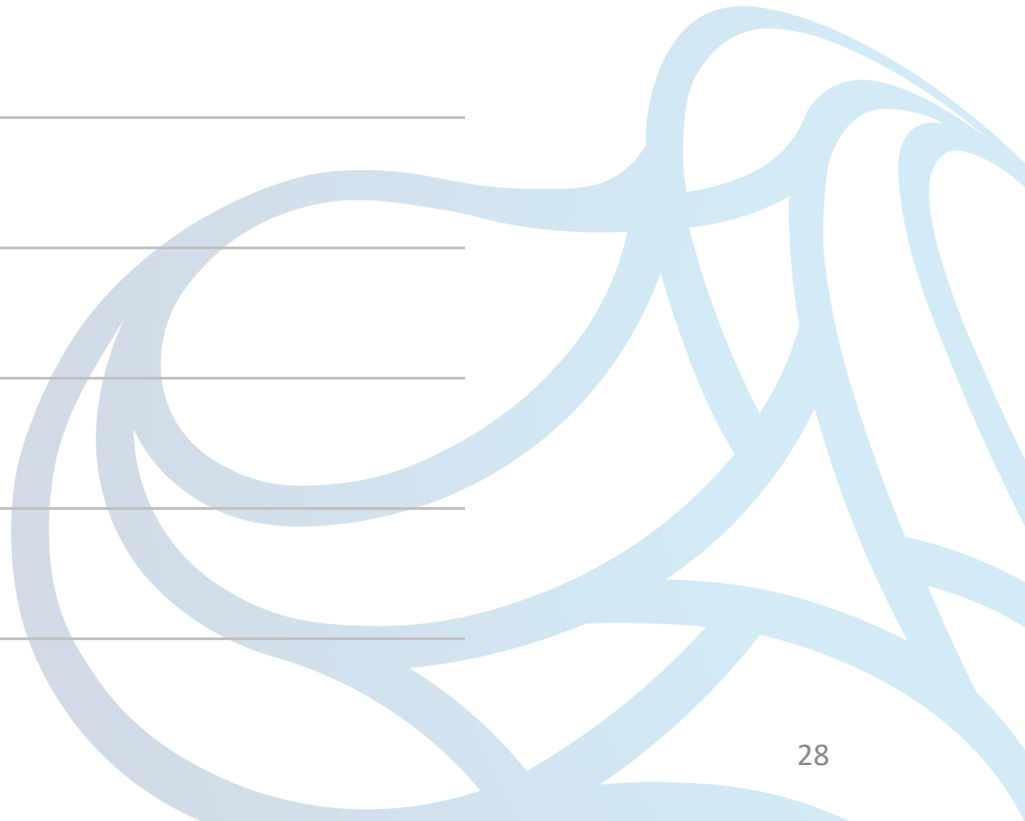
